'positive about equal opportunities' kitemark



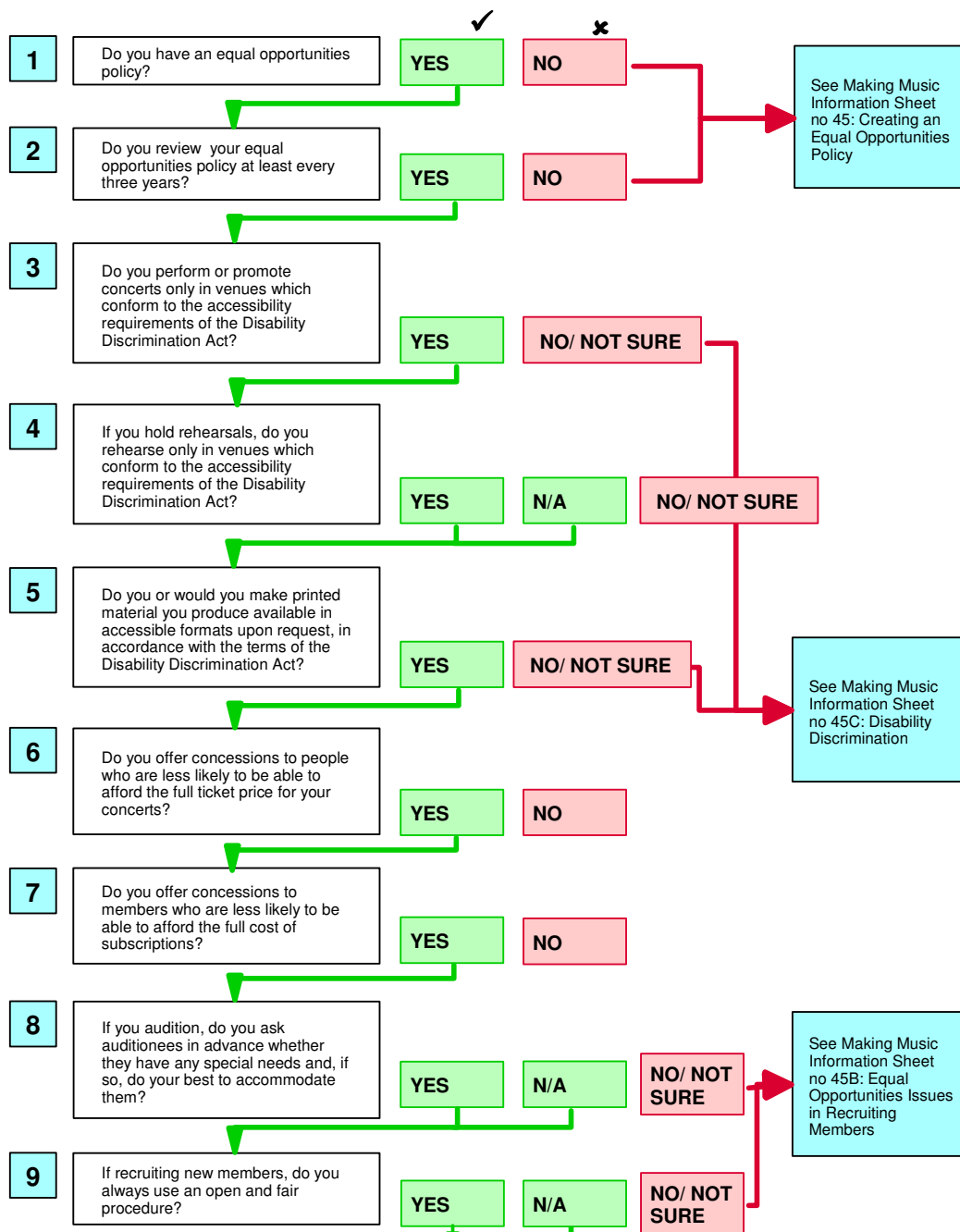
Making Music's **positive about equal opportunities** kitemark provides a checklist for your group to use to assess whether there are further steps you could take with regard to equal opportunities. If you have already taken these steps it also provides an indication to others that you are 'positive about equal opportunities'.

To check whether your group could qualify to use the kitemark please read through the nine questions shown overleaf. If your group can answer 'yes' to all nine questions then you can apply for the award. If successful you will be eligible to display the kitemark logo above on your posters, leaflets and programmes.

To apply for the **positive about equal opportunities** kitemark your organisation needs to:

- be a member of Making Music
- discuss the nine questions at a General Meeting, or at a gathering of at least 75% of the membership of the group (eg a rehearsal), and agree that you can answer 'yes' to all nine questions;
- submit the form overleaf, completed and signed by an officer of your group and accompanied by a copy of the relevant formal minute from the meeting.

Please also refer to Information Sheets 45, 45a, 45b, 45c and 48 for further advice on adopting good working practice in equal opportunities.



CONGRATULATIONS: If you have answered yes to all these questions you are eligible to apply for Making Music's **positive about equal opportunities** kitemark.

To apply for the award please:

- discuss the nine questions at a General Meeting or at a gathering of at least 75% of the membership of the group, and agree that you can answer "yes" to all nine questions;
- complete and return the form overleaf, signed by an officer of your group and accompanied by a copy of the relevant formal minute of the meeting.
